



Life Coverage

We are able to consider applicants with temporary resident status in Canada who have applied for permanent residency and have intention to stay in Canada permanently. A copy of a valid work permit is required and if the work permit is about to expire, proof of extension is required. Please refer to the chart on page 2 for further requirements.

Individuals who have a chronic medical condition that is not being monitored by a doctor in Canada will be postponed. Ongoing medical investigations and treatment outside Canada, other than the immigration medical exam, are not acceptable.

Critical Illness Coverage

Temporary residents will not be considered for critical illness coverage. Critical illness coverage is only available to those applicants with permanent residency status who have been in Canada for at least 1 year with medical records established with a doctor in Canada. Please refer to the chart on page 2 for requirements.

Language Issues

If translation is required for the application and the interpreter is SOMEONE OTHER THAN THE BROKER, we require that the person translating:

- Be an uninterested party NOT related to the Life Proposed or applicant by blood or marriage
- NOT the beneficiary or applicant on the application
- NOT a minor

Turbo Application is only available where the Life Proposed speaks English or French fluently.

If the age/amount requirements call for a paramedical exam, the broker must arrange for a paranurse who understands the same language as the client at time of order. Some parafacilities also provide third-party interpreters as part of their service.
